



## **ELIGIBILITY CRITERIA:**

- 1. The following criteria will be followed for allocation of Elective Subjects to the Students who have passed Class X Board Exam as regular students.
- 2. For the allotment of subjects a student should get the following minimum percentage in the Board Exam:
  - i) For PCM / PCB with Biology / Economics / Phy. Education: Aggregate 70%
  - ii) For Commerce / Applied Mathematics with Physical Education: Aggregate 60%
- 3. Admission to Class XI will be given as per the marks obtained in the Board. If the Student after seeking admission and allotment of stream fail to satisfy the management, he will be allotted a different combination of subjects as per the Eligibility rules. No change of subject(s) whatsoever will be accepted after September.
- 4. A student not having 75% attendance to his / her credit shall not be allowed to appear for the Annual Examination.
- 5. Attested Mark Sheet of Class X and Transfer Certificate be submitted.
